

**Canadian Association of Gift Planners (“CAGP”) COVID-19
General Waiver and Release**

To: Canadian Association of Gift Planners, its officers, directors, employees, agents, successors, assigns, volunteers, and representatives (the “Releasees”).

Re: COVID-19 General Waiver and Release (the “Release”)

I acknowledge and accept that there is a risk that I could be exposed to and/or contract COVID-19 while attending CAGP Foundation’s Advanced Canadian Gift Planning Summit, September 19-20, 2022 (the “Event”).

In consideration of my participation in the Event, I knowingly and freely assume all risks related to exposure to COVID-19, even if such risk arises from the negligence or fault of the Releasees. I voluntarily agree to assume all of the risks and accept sole responsibility for any injury, illness, damage, loss or expense that I may experience or incur if I am exposed to COVID-19 while participating at the Event.

I hereby expressly waive and release any and all claims which I have or may in the future have against the Releasees, on account of injury, illness, disability, death, or property damage arising out of or attributable to my participation in the Event due to exposure to COVID-19. This includes, without limitation, the negligence or breach of any statutory or other duty of care of the Releasees.

I covenant and agree that I shall not make or bring any such claim against the Releasees, and forever release and discharge the Releasees from liability under such claims. This includes, but is not limited to, lost income, the cost of additional nights of accommodation, or the cost of changes to my travel plans, which may arise if I have to self-isolate due to exposure to COVID-19.

If I endanger or expose other Event participants to COVID-19 by: attending the Event while I am exhibiting signs and symptoms of COVID-19; or, while I am subject to an order from a Public Health authority to self-isolate; or, misrepresenting my vaccination status to the Releasees; or, failing to follow applicable Public Health requirements while attending the Event, I shall defend, indemnify and hold harmless the Releasees against any and all losses, damages, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs, or expenses of whatever kind, including reasonable legal fees, in connection with any third-party claim, suit, action or proceeding that may arise as the result of my actions.

This Release is binding on and shall enure to the benefit of the Releasees and me and our respective heirs, executors, administrators, trustees, legal and personal representatives, successors and assigns.

I acknowledge that I have carefully read and understood all of the terms of this Release and that I am voluntarily waiving substantial legal rights including the right to sue the Releasees in the event that I am exposed to COVID-19 while attending the Event.

As lawful consideration for being permitted by CAGP to participate in the Event, I agree to all the terms and conditions set forth in this Release.
