

Take Advantage of CAGP's New Organizational Membership Category

Charities are often faced with budgetary choices in regard to their professional development needs. As of February 1st, the Canadian Association of Gift Planners (CAGP) will be launching a renewed membership structure with a variety of categories. One category designed to bring excellent value is the new Organizational Membership.

CAGP is offering a discounted membership rate to single organizations with four or more members. Pricing is as follows:

- Four members \$1,000
- Five to ten members an additional \$250/member
- More than ten members an additional \$200/member

This new category will enable member organizations to take advantage of the CAGP membership for more of their staff, for very little additional cost. For example, if you are a single organization with 3 staff who are CAGP Associate Members the cost for renewal would be \$975 (Charity/Nonprofit Associate Member fee is now \$325.00). Switch to the Organizational Membership and, for \$25 you add a 4th member, or for an additional \$250, you can include a 5th. That means, for less than the cost of an additional single Associate Membership, two more of your staff can be part of CAGP's network. Beyond your planned giving team, this may be the perfect time to consider including other fundraising staff, your CEO or other senior team members, finance staff, leadership volunteers, or perhaps others that you may not have considered, but who would greatly benefit from a better understanding of the opportunities and mechanics of a strategic charitable gift planning program.

This is what one CAGP member had to say about why they decided to take advantage of the new Organizational Membership category:

'The new CAGP membership category has opened the door for me to encourage several other staff members to take advantage of the extensive CAGP membership offerings. We now have a fourth staff person joining and others are seriously considering membership.
