Renovations and new furnishings create home-like settings in our more traditional older care centers, while adaptive vans open the doors for residents and clients, educational bursaries and scholarships help staff grow, and programs for our continuing care operations are supported through CapitalCare Foundation, ensuring that both residents and staff have opportunities to enrich theirs and others lives.

- Good interpersonal skills: excellent verbal and written communication skills.
- Proven ability to be detail oriented with excellent analytical, problem solving and project management skills.
- Demonstrated innovation and change management skills which include supporting and encouraging new ideas and approaches.

Other Requirements

- Ability to work independently from a remote office when needed.
- Travel within the Edmonton region required.
- Presence and participation at various meetings (some evenings and weekends).
